#### **EXHIBITOR:**

  assign or sublet the stand space or any part thereof. In addition the Exhibitor may not assign or transfer
  any of its rights or obligation under this agreement without the prior approval or written consent of the
  Organizer.
- The Exhibitor will not be allowed to take over their space unless payment terms specified on the application are fulfilled.
- Exhibitor's display shall be placed within the contracted space area and shall not in any manner obstruct
- or be offensive to other Exhibitors or visitors.
- The Exhibitor will be responsible for any damage to the walls or floors in their designated area.
- The Exhibitor will comply with all rules and regulations of the authority having control over the building.
- The Exhibitor will keep clean and tidy the space occupied to the satisfaction of the Organizer.
- No electrical work will be undertaken by the Exhibitor without the consent of the Organizer and then, only by an electrical contractor approved by the Organizer.
- All Exhibitors' stands with display material above 2.4 meters must submit design plans to the Organizer
- for prior approval 2 months before the event.
- All Exhibitors with open/raw space must submit design plans to the Organizer for approval 2 months
  prior to the event.
- All product and equipment must be insured by the Exhibitor.
- The Exhibitor must follow the operation schedule stated in the Exhibitors Manual.
   This will be issued 2 months prior to the Exhibition.
- Contracting parties for group stands are responsible for ensuring that all Exhibitor within their group
  are fully aware of and agree to abide by these Terms and Conditions and by the Rules and Regulations
